Late Payment	\$990 (GST inclusive) if made after 5pm on 27 November 2015 and prior
	to 30 June 2016 - for those who did not make an Early Bird Payment.
Final Payment	\$550 (GST inclusive) Prior to 30 June 2016.

To be eligible to win bonuses, Early Bird or Late Payment AND Final Payment must be made.

## ELIGIBILITY B BREEDBACK

Foals by any stallion, provided the dam is covered by a Queensland domiciled stallion the following season.

#### NOMINATE TO QTIS

Late Payment	\$990 (GST inclusive) if made after 5pm on 27 November 2015

# PLEASE NOTE

- All yearlings nominated for the scheme and for which an Early Bird Payment is made by 5pm on 28 October, will have the QTIS logo accompanying their horse pedigree in the Magic Millions catalogue at the sale in January 2016. Any such horse will also have a 'QTIS nominated' badge displayed on it at the sale.
- For the Early Bird payment a one-off extension will be made with the final deadline for Early Bird Payments being 5pm Friday 27 November. All nominations received after this date will be considered in the 'Late payment' category.
